Chair reiterated limited subject matter to be addressed: allow board to discuss property acquisition and consider legal action against property owner before entering closed session. Time of entering closed session was 8:18am

CLOSE EXECUTIVE SESSION:

MOTION: Sharp moved, Winkler seconded, to close executive session. Motion carried 5-0. Meeting reconvened in open session at 8:32am. Chair announced that the only topic discussed in closed session was property acquisition and consider legal action against property owner (item 5B.) There was no action taken in closed session.

5. Road Matters-Lenny Thorne, Highway Superintendent:

5A. Discuss/Action- John Gade- Strand Associates, Inc. and Emily Bausch- City of Plattsmouth, Main Street Construction Project request to install temporary traffic detour signing. Gade discussed project with board members on proposed detour and estimated start date of December – January, board members addressed concerns with detouring semitrucks on Wintersteen Road and River Road in winter months- both roads are not ideal for increased head-to-head traffic during winter months due to ice/snowpack conditions causing an increased risk to the county. Commissioners asked that Mr. Gade work with contractor and Thorne to discuss other options for traffic during construction.

Gade also discussed Plattsmouth Water Supply Contract 3- Water Transmission line and ROW permit with Commissioners, (item was in inadvertently left off of agenda). Board reviewed request and asked that the item be placed on the November 5th agenda as an action item. Mr. Gade will not be required to attend the meeting.

5B. Executive Session- Consider Legal Action against property owner on River Road. Combined in executive session with item 4B

6. New Business & Unfinished Business:

6A. Discuss/Action- Mike Jensen-Zoning Administrator, Map Change ZP-2024-0018; parcel 130101109. Applicant/owner: SK Investment Trust; Legal: L15 & 16 EXC HWY & PT DB107 P487 E1/2 NE1/4 15-12-09 (tabled 10/8/24). Jensen reviewed application which meets zoning regulations, noting this is a change from TA (Transitional AG) to IA (industrial AG). Planning Commission denied recommendation by a 4-1 vote. Applicant Scott Steven appeared to outline proposed use

of indoor/flex storage on parcel. (1) Adjacent property owner spoke regarding concerns of dust, increase in deputy presence due to possible increase of crime in area and effect of values of home in area. Board noted some concerns could be addressed within the Conditional Use Permit (C.U.P.). Discussion continued between Jensen, Perrone and board members, if zoning change is denied, applicant could apply for a Conditional Use Permit in current Trans Ag MOTION: Murdoch moved, DeGarmo seconded to deny zoning change as requested. Motion failed 3-1, Murdoch voting yes, Sharp, Boyle, Winkler voting no, DeGarmo abstained.
